## Property Tax Deductions

A deduction of \$250 is available to those residents age 65 years of age or older, who have owned their homes since October first of the previous tax year, lived in the state for two years and whose income (excluding Social Security or other similar government pension) does not exceed \$10,000. For additional information, call your local Tax Assessor's Office.

## Cleanout & Move-out Fees

Contents from entire cleanout of dwellings cannot be put at curb until a fee of \$250 is paid to the Township of Berkeley and arrangements for collection have been made with the Department of Public Works. Mattresses must be enclosed in bags.

Hope this message finds everyone well and still reeling in the Holiday spirit. The little child in all of us that we try to hold on to forever.

So, at the end of 2025, Mother Nature showed all of us her unpredictability. Instead of receiving a 3-to-5-inch light leaf blower snowstorm. She hammered the State with a 7-to-9-inch heavy wet snow. As we have promised from the time we took office, we would be aggressive in outstanding dues collection. It is a fiduciary responsibility we have to all the residents, which pay their dues on time and in a timely fashion. Outstanding dues statements and letters have been sent out multiple times to those in the arrears. Many residents have brought their dues current, stating a misunderstanding with the dues increase of 2025 as a factor and other reasonable explanations. For those residents who simply fail, ignore or refuse to pay their dues, unfortunately the Association will be taking more formal action as outlined in the SRPW By-Laws. As you may or may not know, we meet monthly with the Senior Coalition of Berkeley Township.

It is comprised of representatives from the ten (10) senior communities in the Township. Almost every meeting, someone discusses how volunteer staffing

is sharply falling off. I cannot thank those enough, who volunteer their precious, valuable time to this community. I would like to take this opportunity to thank Michael Pelonero for all he has done for us and the community. He filled the vacant Treasurer's position and was always a reliable, dependable source of information. We are always in need of and looking for volunteers from any background. However, we are especially in need of those with code enforcement and construction backgrounds.

Thank you for your continued cooperation and support. Your feedback and participation remain invaluable. If you need any help or assistance, please feel free to reach out to any of the Board of Trustee members.

## Dues Assessments

The first-quarter dues payment of 2026 are due on January 1st. A late fee of \$15 will be added to your account on the 1st of the next month if dues are not paid on time. Association dues assessments are payable on or before the first day of a given quarter. To ensure that your dues payments are posted correctly, your payment must be accompanied by a dues coupon containing all of the required information. Be sure your information is legible. Payments may be sent to the Clubhouse by mail, brought to the Treasurer's office or placed in the dues box on the main floor of the Clubhouse. **Dues coupons are available at the Clubhouse and are published in The Sentinel.**

As a homeowner, your obligation to pay dues continues as long as you own your home and it is the homeowner's obligation to pay dues for renters. Individuals residing in your home with you on a permanent basis ("permanent" defined as a stay of more than 90 days) must be 19 years of age or older and are obligated to abide by the Association's governing documents. Also, remember, if you own more than one home, each property is subject to dues.

# Dues Coupons

January 1, 2026 homeowners dues are \$72 per quarter per living unit. Payments are to be made at the beginning of the quarter. January 1, 2026, April 1, 2026, July 1, 2026 and October 1, 2026. If you pay semi annually the payment would be \$144 on January 1, 2026 and July 1, 2026. Annual payments are \$288 due on January 1, 2026. Make checks payable to Silver Ridge Park West Homeowners Association and mail or drop off in the mail slot at the Clubhouse, 145 Westbrook Dr., Toms River, N.J. 08757

Note: All payments must be accompanied by a fully completed dues coupon. A late fee of \$15 will be added to your account on the first of the next month after the due date if dues are not paid on time.

Meeting minutes

December 8, 2025

**Rich Laird, President:** Thank you very much for coming tonight. Can all stand for the Pledge of Allegiance.

**Pat Lima:** Opening prayer

**Rich Laird, President:** Thank you, Pat.

**Virginia Sansone, Secretary:** Roll Call: President. Here. Vice President. Here. Secretary here. Section 5, absent. Section 6. Here. Section 7. Here. Section 8. Here. Section 9. Here. Section 10. Here. Section 11. Here. We have a quorum.

**Rich Laird, President:** Good evening, everyone. One of the things that we've come across, and I want to clarify some issues with the Robocall that went out. We've had a decrease in the number of people paying dues. We have 383 residents that have not paid their dues and not just this year, but for the last few years. We have close to \$72,000 outstanding in dues. We're going to get very aggressive in dues collection. But there's some confusion this year. At the beginning of the year, the budget was not approved for the first quarter. So, several residents, 183 residents, were short \$36 because they weren't aware that the dues went up in April. And a robocall went out, and it was just to notify people that if you paid \$240, that wasn't the correct amount. It should have been \$276. So, what we're going to do, again, is follow that up with a nice letter to them, say, thank you, for paying your dues ahead of time. But being that the dues went up on April 1st, they're still short \$36. We also have several residents that thought they got a refund because checks were returned. And being that the budget wasn't approved, the dues weren't \$288, the checks were returned. We're going to be very aggressive this year in trying to collect money that's due to us, which will include, just so you're aware, liens and foreclosure notices. We have people that have years of not paying dues. We have new residents that aren't paying dues. We are finding this out by running delinquent payment reports and when they want to do architectural control work, they come in with their paperwork, they have a year's dues they haven't paid.

I'm going to need a motion to accept the November minutes. Second. All in favor? Aye. Opposed? Okay, the minutes are approved.

A resident brought up a question last meeting about governing documents and what authority people have in changing documents in our association. The declaration of covenants and restrictions and bylaws, when changing, the residents vote on those changes. Rules and regulations, those fall under the board. The board has the authority to



address the rules and regulations and change them as they feel fit for the community, for the association. So, it's not something that goes out to the residents. Now, the residents can have an opinion on it. Whether or not people know it's there or not, all our governing documents are on our website. If you don't have a computer, you don't have internet access, nothing stops you from coming here and getting a copy of any of the documents, we'll provide to you.

We're going to start taking a roll at the homeowners meeting. According to bylaws, if you are 30 days out, and your dues are not paid you're not supposed to be attending the homeowner meeting. So, what we're going to do is, go with it, if you come in, you owe us dues, you pay the dues, you can attend it, I just think it's something that we need to do as an association to work through that. But if you come in, you don't want to pay your dues, you are not going to be allowed to attend the homeowner's meeting.

The veteran breakfast will be run by Hospitality, Recreation, and the Homeowners Association.

I received an email from the mayor's office about a company that wants to go around soliciting in our community. And I was like, wait a second. I said, our bylaws prohibit people from soliciting in our community. Guess what? They supersede our bylaws. On the Berkeley Council website, there's a no-knock form. You fill that no-knock form out, they provide your address to the solicitor so that they're not allowed to knock on your door. And you get a sticker to put on your door window so that they are not allowed to be there. Solicitors are only allowed to come into our community to solicit if they have a permit between 11 and three. Not eight o'clock in the morning, not six o'clock at night. If that happens, call the police, and they will take their license.

I just want to jump here to our proposed bylaws. They're under attorney review. The only reason the attorney's looking at it, not to change anything that we have, just to make sure that we completely comply with not only Radburn, but the Nonprofit Act and the New Jersey Administrative Codes. So that we don't put something out there and somebody says, wait a second, this is a violation of such and such.

Debi Tobia: Hi everyone. I do want to clarify this proposal for the garden fences. There was a November 1st ruling that you had to take your fencing down. I propose that you don't take it down because everybody here has bought expensive shrubs and flowering shrubs and I want you to be able to protect them all year round. The only thing I'm saying in my proposal is that let's unify the fencing. Not expensive fencing. But let's kind of unify it because you see a lot of chicken wire, you see a lot of construction fencing put up to protect or netting,

so my proposal is to keep the temporary fencing up all year round and to unify it. And not only in the front.

**Esther Perez; Vice President:** Hi everyone. So, for common grounds, we are not doing common grounds right now. We go out on Fridays to check trees and common grounds. We went out last Friday and looked at 13 homes. Continue to fill the grounds forms, because we use this for documentation. Emergency contact. We're going through all the files, I'm not, but Ruth is going through all the files. HOPA forms are now new for 2026. Do me a favor, please, next time you pay your dues, come in with a new HOPA. They're on the website and in the Sentinel. I have copies here at the clubhouse for you. We will need a copy of your driver's license, which we'll make a copy here for you. This way we can get it in the file. Robo calls, we hardly have anybody signed up for those. So, if you want to be notified of issues, please fill out the robo form.

**Virginia Sansone, Secretary:** The only thing I have is regarding the Sentinel. If you guys have anything that needs to go to the Sentinel, I need to have it by this Wednesday at the latest. As far as the website is concerned, we're still working on that thank you.

**Trustee reports. Brian Trustee Section 6:** I had a phone call from the homeowner and homeowner and apparently her neighbor has four cars and only one is parked in the driveway. There's nothing in their garage. And the other three cars are parked on the gravel, and she wanted to know if that's permitted or not. the driveway.

**Rich Laird, President:** That issue has already been addressed and corrected. However, the resident is allowed to park on the street.

**Debi Tobia, Trustee Section 7:** Quiet,

**Bob Sellitto Trustee Section 8:** There were no new violations.

**Shirley Emmons Trustee Section 9:** nothing to report.

**Tom Kalinowski , Trustee Section 10:** Quiet

**John Fegan, Trustee Section 11:** Quiet

**Jim Egan, ADR:** I'll be talking to Judy soon, and the three or four members that want to join the ADR committee

**Diane Nase, Recreation:** Everything's great.

**Vivian Evan Food bank:** The doors are just ready to burst out. The generosity of this community has been outstanding.



**Virginia Sansone, Neighborhood Watch** They have gone from 300 residents that cannot take their garbage cans out, up to 900 residents. So now, starting in January, because every year you must renew it, you must bring you're a copy of your handicap registration to the township. You need the registration card to have your robo cans moved by the township. No longer is a doctor's note accepted.

**Maria Brush, Women's Club:** We had a great Christmas party, and we acknowledged some of the older women at birthdays speaking about the food pantry. Barbara Gannon is up there in age, you know, and she still participates. I gave her a certificate. We're going to have a great time on New Year's Eve and we have a lot of good stuff planned for the New Year's Day.

# FOR YOUR INFORMATION

## ARCHITECTURAL CONTROL COMMITTEE

The Architectural Control Committee is a standing committee and operates under the guidance of the SRPW HOA By-Laws, Declaration of Covenants and Restrictions, and Rules and Regulations.

According to Article V, Section 1 of the Declaration of Covenants and Restrictions: No building or other structure, fence, wall, swimming pool or any other structure, either of a permanent or temporary character, shall be erected, moved on, installed, commenced or maintained , upon the properties nor shall any exterior addition to or alteration be made to any existing building or structure unless the plans and specifications thereof, showing the nature, kind, shape, height, materials and location of same, shall have been submitted to and approved in writing as to harmony, as to exterior design, and location of surrounding structures and topography, by the Architectural Control Committee of the Association which shall consist of either (1) The Board of Trustees of the Association, or (2) a committee composed of not less than three (3) persons appointed by the Board of Trustees of the Association.

Process by the Committee Members:

1. Provide HOA paperwork and assist homeowner with preparation of same.
2. Do preliminary site survey and discuss with homeowner planned improvements.
3. Collect homeowner's completed paperwork.
4. Present paperwork to HOA officers for approval and be available to discuss with officers.
5. Collect officer's signatures for approval.
6. Provide homeowner with copies of approval to proceed.
7. Maintain contact with homeowner.
8. Resident to contact Architectural Control upon completion of job Review project upon completion.
9. Return completed paperwork to HOA office for the permanent files.
10. Maintain tracking worksheet with progress.

Violations of the HOA Covenants and Restrictions:

1. STOP WORK order to cease work in progress
2. Delay in approval of proposed work
3. Possible non-approval of proposed work
4. Fines by the HOA for non-compliance, not to exceed \$100 per violation
5. Fines by Berkeley Township for code violations

# Berkeley Township Construction Permits

No construction permit shall be issued for the alteration of the exterior of any residence or addition to such residence, or construction of accessory structures located within any planned residential retirement community, unless the application for such permit is accompanied by a written statement issued by the association organized under subsection 35-101.12 of this section, indicating whether the association has approved the proposed improvement. In the absence of such approval the Construction Official may if otherwise required to issue the permit pursuant to the Uniform Construction Code note on the permit that the applicant must obtain such approval before beginning construction.

# PROPERTY ASSESSMENT REVALUATION

It has been almost fifteen (15) years since a revaluation was completed in the Township of Berkeley New Jersey. Real estate taxation law mandates that all real estate be assessed at 100% of market value and there must be equalization among assessments.

Annually, the State of New Jersey, Division of Taxation, and the Ocean County Board of Taxation complete a study of all the sales that have transacted in each community, including the Township of Berkeley, and determine the relationship of assessed value to sale value for each usable sale.

It has been determined by the State and County agencies that the properties located within the Township of Berkeley are currently not assessed at market value. The Ocean County Board of Taxation has ordered a revaluation of the Township to be completed and implemented by the 2027 Tax Year.

Some of the major forces responsible for causing inequity in assessments are inflation and neighborhood trends. As a consequence, all properties have not increased in value at the same rate since the last revaluation; hence, imbalances have been created.

We have prepared this brochure to help you understand the process that takes place during a revaluation program. In addition, it is an attempt to answer some basic questions and to clear up common misconceptions.

### 2026 HOPA SURVEY

As a requirement of the Housing for Older Persons Act (HOPA) the Association must conduct a survey of all Association members by affidavit every two years to ensure that we qualify as an over 55 senior community. Section 100.307 of the Code of Federal Regulations states: The procedures described in paragraph 100.307(b) of this section must provide for regular updates, through surveys or other means, of the initial information supplied by the occupants of the housing facility or community. Such updates must take place at least once every two years. A survey may include information regarding whether any units are occupied by persons described in paragraphs (e)(1), (e)(3), and (e)(4) of §100.305. (CFR-Title 24 Housing and Urban Development)

The below survey form must be completed and returned to the Clubhouse Office along with a copy of one of the below listed forms of proof of age for each resident by May 1, 2026. Noncompliance can result in fines as stated in Bylaws Article VI 6.01 (q) and enumerated in Article XI.

## FREQUENTLY ASKED QUESTIONS

- 1 **What is the purpose of the Property Alert Service?**  
The Property Alert Service is a way for property owners or other interested parties to receive alert messages by email when a document that affects a specific property is recorded by the Clerk's Office. The service matches data (municipality, block number, and lot number) in legal descriptions on recorded documents with requests made by subscribers.
- 2 **Can more than one person register the same property or party name?**  
Yes. There is no limit to the number of subscribers for a particular property legal description or party name.
- 3 **Why should I register for this service?**  
This service is for individuals who want to know if fraudulent activity will occur under their name or on property located in Ocean County. You may also wish to register the name or legal descriptions for property of elderly loved ones to help protect them from scams.
- 4 **Does the property need to be occupied in order to receive an alert?**  
No. The property alert service is for any type of land owned in Ocean County, whether occupied or vacant.
- 5 **What recorded documents are included for the alert notification?**  
Any document with a legal description pertaining to real property is included.
- 6 **Why can't you stop the fraudulent document from being recorded?**  
As long as a document meets statutory recording guidelines, New Jersey law requires the Clerk's Office to record the document. Recordings cannot be refused unless guidelines are not met.
- 7 **What do I do if the document recorded is fraudulent?**  
If you find a document recorded against your name or property is fraudulent you should contact your attorney or law enforcement officials.

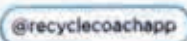
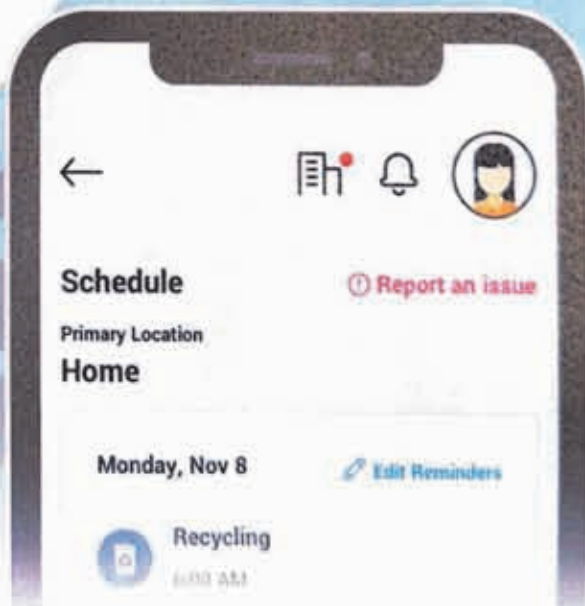



# TECH SUPPORT SCAMS

You get a *PHONE CALL, POP-UP, or EMAIL* telling you there's a problem with your computer.

Often, scammers are behind these calls, pop-up messages, and emails. They want to get your money, personal information, or access to your files. This can harm your network and put your computer data at risk.

## HOW THE SCAM WORKS:

The scammers may pretend to be from a well-known tech company, such as Microsoft. They use lots of technical terms to convince you that the problems with your computer are real.

They may ask you to open some files or run a scan on your computer — and then tell you those files or the scan results show a problem...*but there isn't one.*

## THE SCAMMERS WILL THEN:

ask you to give them remote access to your computer — which lets them access all *information stored on it*. They will then install malware that gives them access to your computer and sensitive data, like user names and passwords. They will try to sell you software or repair services that are worthless or available elsewhere for free. They will try to enroll you in computer maintenance or warranty programs and ask you to pay with a credit card or gift card for phony services. They will direct you to websites and ask you to enter credit card, bank account, and other personal information.

## How to PROTECT yourself:

If a caller says your computer has a problem, hang up. *A tech support call you don't expect is a scam — even if the number is local or looks legitimate.* These scammers use fake caller ID information to look like local businesses or trusted companies. If you get a pop-up message to call tech support, ignore it. Do not call a number or click on a link that appears in a pop-up message warning you of a computer problem. If you're worried about a virus or other threat, call your security software company directly, using the phone number on its website, the sales receipt, or the product packaging. Never give someone your password, and don't give remote access to your computer to someone who contacts you unexpectedly.

## WHAT TO DO IF YOU'RE SCAMMED:

If you shared your password with a scammer, change it on every account that uses this password. Update or download legitimate security software. Scan your computer, and delete anything the software says is a problem. If you need help, consult a trusted security professional. If you bought bogus services, ask your credit card company to reverse the charges, and check your statement for any charges you didn't approve. Keep checking your credit card statements to make sure the scammer doesn't try to re-charge you every month.





**Scammers PRETEND to be from an organization you know.**

Scammers often pretend to be contacting you on behalf of the government. They might use a real name, like the Social Security Administration, the IRS, or Medicare, or make up a name that sounds official. Some pretend to be from a business you know, like a utility company, a tech company, or even a charity asking for donations.

They use technology to change the phone number that appears on your caller ID. So the name and number you see might not be real.

**Scammers say there's a PROBLEM or a PRIZE.**

They might say you're in trouble with the government, or you owe money, or someone in your family had an emergency, or that there's a virus on your computer.

Some scammers say there's a problem with one of your accounts and that you need to verify some information.

Others will lie and say you won money in a lottery or sweepstakes but have to pay a fee to get it.

**Scammers PRESSURE you to act immediately.**

Scammers want you to act before you have time to think. If you're on the phone, they might tell you not to hang up so you can't check out their story.

They might threaten to arrest you, sue you, take away your driver's or business license, or deport you. They might say your computer is about to be corrupted.

**Scammers tell you to PAY in a specific way.**

They often insist that you pay by using cryptocurrency, by wiring money through a company like MoneyGram or Western Union, or by putting money on a gift card and then giving them the number on the back. Some will send you a check (that will later turn out to be fake), then tell you to deposit it and send them money.

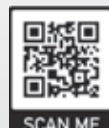

# Preventing Slips, Trips & Falls

## KNOW THE RISKS

Slips and trips are two of the most frequent causes of injury in the workplace and cost employers millions every year. However, the majority of accidents caused by slips and trips can be easily avoided by following a few simple guidelines. By following the principles set out in this poster, you can ensure that your workplace is free from slip and trip hazards and that accidents are kept to a minimum.



## 1. HAZARD - SPILLAGES

### Spillages

Clean spills up at once. Remember that the cleaning agent needed will depend on the nature of the spill. If the floor remains wet after the spill has been cleaned, make sure people are aware of this by using appropriate signs. Arrange a diverted route that avoids the area if necessary.



## 2. HAZARD - CABLES

### Cables

Try to make sure that cables do not cross walkways. Use cable curbs and tunnels to prevent trips if necessary.



## 3. HAZARD - OBSTRUCTIONS

### Obstructions

Permanent obstructions and any objects left lying around can easily create a trip hazard if they are not seen. Keep work areas clear of obstructions. If this is not possible, use appropriate signs or barriers to make people aware of hazards.



## 4. HAZARD - FLOORING

### Flooring

Look for any cracks, holes or uneven wear etc that may cause a trip hazard. If the floor regularly becomes wet or slippery through working procedures, consider how this can be contained or prevented.



## 5. HAZARD - FOOTWEAR

### Footwear

Choice of footwear can be crucial in preventing slips and trips. If special footwear is needed to ensure the safety of employees, the employer must provide it.



## 6. HAZARD - LIGHTING

### Lighting

Lighting should be adequate enough to enable people to see obstructions and hazards. Ensure that faulty lights are replaced and dirty lights are cleaned before levels become too low for people to work in safety.



## 7. PREVENTING ACCIDENTS

An effective management system will enable you to:

- Ascertain any slip and trip problems.
- Identify the best course of action.
- Execute your chosen course of action.
- Evaluate the effectiveness of your precautions.

You should try to incorporate the following steps into your system:

1. Ask which areas of your workplace contain slip and trip hazards and devise a strategy for improvement. Minimise slip and trip hazards through effective equipment and working procedures.
2. Make sure workers are aware of slip and trip risks and are committed to minimising them. Give people safety responsibilities. Ensure a record is kept of who is responsible for what.
3. Carry out regular checks to ensure that any safety procedures are being carried out properly. Keep a record of cleaning and maintenance work.
4. Review the approach to slip and trip issues on a regular basis and examine accident reports.
